



## TAB Show Day Punter Of The Year (POTY) Friday 14 November 2025

## Terms & Conditions

 An official entry form must be completed stating the name / s of participants / syndicate members including the Syndicate Manager (if applicable) and contact particulars to confirm entry. A nom de plume may be used for publicity purposes.

A syndicate can be up to a maximum of four (4) participants. There is no entry fee to enter the challenge.

All participants / syndicate members must be aged 18 or over.

- \$600 of betting funds validates entry and must be loaded onto a participant's on-line TAB Account no later than 30 minutes prior to Race 1. Only one TAB Account to be used per participant / syndicate. You will be asked to verify these funds.
- Entain New Zealand Limited (TAB) is supplying the Platform, as defined in the TAB General Terms and Conditions for Accounts, for use in the Competition only. The administration, responsibilities and liabilities of this Competition rest solely with NZMTC.
- A Restricted Punter will be limited to the winnings set by the TAB.
- Customers who are excluded from TAB products, including self-exclusions, or deemed promotion ineligible are not eligible to participate in this promotion.
- 6. Minimum of \$50 to be invested on each race on the programme.
- If the balance of the TAB on-line account is less than \$50, the entire amount shall be invested on the next race.
- Once funds have been used no additional monies can be added.
- A maximum of 250 participants will be taken on a first-come, first-served basis.
- 10. There is no limit to the number of entries that one participant / syndicate can make in the competition as long as each entry has its own individual name or non de plume, is able to be clearly identified and uses a different TAB on-line account for each entry.
- Each participant / syndicate must appoint a manager who is the official representative of the participant / syndicate and is the sole point of contact for any of the POTY Challenge related communications.
- 12. All participants / syndicates must be in the dedicated room / marquee at Addington Raceway 30 minutes before the first race.

- 13. A bet in any given race must be placed at least five (5) minutes prior to the start of the race.
- 14. In the event of an inquiry, which is not resolved prior to five (5) minutes before the start of the next race, any participant / syndicates whose funds are held up because of the enquiry and who has less than \$50 of funds available, shall not be disqualified, but shall resume investing on the race after the enquiry has been resolved.
- 15. All bets are to be placed on races 1 to 12 at the NZMTC race meeting on the 14th of November.
- 16. The leaderboard will be updated regularly. When asked, all participants / syndicates must provide the challenge organisers with an accurate balance of their TAB on-line account. Any participant / syndicate who, in the opinion of the organisers, deliberately withholds back the balance in an attempt to lessen their position on the leaderboard will be disqualified.
- 17. The winner shall be the participant / syndicate with the highest balance after dividends of the last race.
- 18. In the event of a tie, the prize money will be split between the winners.
- 19. Before any prizes are awarded participants / syndicates will allow the challenge organisers full access to their transaction history on their TAB online account to verify that all competition rules and requirements have been met.
- 20. If, for any reason, the race meeting is abandoned, the participant / syndicate that has the highest balance at the time the meeting is abandoned shall be declared the winner and prizes will be paid out as per condition 16.
- 21. If, for any reason, the entire race meeting is cancelled, participants / syndicates shall be notified either verbally or in writing by way of their contact details and notified through addington.co.nz.
- 22. The NZMTC reserves the right to cancel this challenge if less than 20 entries are received. Participants / syndicates shall be notified either verbally or in writing by way of their contact details and notified through addington.co.nz.
- Participants / syndicates accept that their name or nom de plume and image may be used for publicity / media purposes.
- 24. A meal will be provided, and a cashless (card only) bar will operate. This is exclusively for participating participants / syndicates.
- No host venue employee, official or spouse / partner may enter. This excludes any person acting in a voluntary capacity.
- 26. By entering the POTY Challenge, you are consenting to receive further information from both the NZMTC and consenting to appear in a reasonable amount of advertising and publicity.

- 27. TAB General Terms and Conditions for Accounts, Promotional Terms and Conditions and TAB Betting Rules apply to this Competition.
- 28. The NZMTC reserves the right to disqualify, in its sole discretion, any participants who are not participating in the spirit of the promotion.
- 29. The NZMTC reserves the right to alter any of the above rules and conditions if it deems necessary. Their decision shall be final.
