TERMS AND CONDITIONS OF COMPETITION

By participating, entrants agree to be bound by these terms and conditions. Information on how to enter and other details form part of these terms and conditions.

1. To participate in the Members' Prize Draw, entrants must be a financial member of the New Zealand Metropolitan Trotting Club Inc (NZMTC).
2. Competition period: Occurs with the competition period being advertised at addington.co.nz/members
3. Dates of the Prize Draws will be available on the members page of the Addington Raceway website (addington.co.nz).
4. If an entrant is unable or refuses to take part in any element of this competition, NZMTC reserve the right to discard that entrant's entry and proceed as if that entrant had not entered the competition.
5. Entrant Criteria: The following criteria applies. Entrants must fulfil the criteria and acknowledge that they understand and agree to abide by the criteria to enter the competition:
 - a. Entrants must be at least 18 years of age.
 - b. Entrants must be a New Zealand resident and living in New Zealand during the competition period.
 - c. Entrant must be a financial member of the NZMTC.
 - d. Entrants must have made a purchase in the Members' Room during the competition period.
 - e. After making a purchase in the Members' Room, entrants must write their name and NZMTC Membership Number on the provided Members' Prize Draw entry slip, or on the reverse side of their receipt.
 - f. All prizes awarded to the entrant must remain the property of the entrant and are not transferable, exchangeable, or redeemable for cash.
6. NZMTC will communicate to members through Addington Raceway emails content published on the Addington Raceway website (addington.co.nz). This may include the date and time of the next prize draw, along with the allocated Members' Room for the upcoming race meeting.
7. All winners may be required to have their photograph taken. By entering the competition, you are consenting to appear in a reasonable amount of advertising and publicity, where required. NZMTC may upload an assortment of selected images of the entrants along with their first name and details of prizes onto the Addington Raceway website or their social media pages during the competition period.
8. NZMTC reserve the right to not upload or remove any entrant's selected images in their absolute direction, including if, in the opinion of either NZMTC or their Major Sponsor (Lamb & Hayward), the selected images include objectionable content, profanity, or are potentially insulting, inflammatory or defamatory.
9. By entering the competition, each entrant acknowledges that NZMTC will own the copyright in all photographs and selected images as part of the competition and may use such photographs or selected images as they see fit, including in any marketing, media, or promotional materials.
10. Prizes are not transferable and are not redeemable for cash.
 - a. All prizes are to be collected on the prize draw night.
 - b. Prizes are at the discretion of the NZMTC and may change without any notice.
 - c. If the winner is not in the allocated Members' Room during the Prize Draw;
 - i. The prize may be held aside for the winner if an NZMTC staff member operating the Prize Draw is aware they are on-course during the draw; or

- ii. The prize may be re-drawn after a time decided by the NZMTC staff member operating the Prize Draw.
11. If NZMTC become aware after an entrant has won a prize, that the entrant has not complied with these terms and conditions or that their entry is otherwise invalid for any reason, that entrant will have no entitlement to the prize, even if NZMTC has announced them as a winner and that entrant will be required at the direction of NZMTC, to return, refund or otherwise make restitution of the prize.
12. If, for any reason, the competition or any of the prizes are not capable of being run or offered as planned, NZMTC reserves the right in its absolute discretion to take any action that make be available to it. Actions may include cancellation, termination, modification, or suspension of the competition. If the competition is not capable of being run, NZMTC will not be liable for any loss or damage of any kind to its entrants arising out of any resultant action taken by NZMTC.
13. If any part of the competition is cancelled, abandoned, or postponed, in whole or in part, for any reason that is beyond NZMTC control, no obligation is assumed by NZMTC for the arrangement of substitute competition.
14. If NZMTC does provide a comparable substitute competition on a rescheduled day or at a rescheduled time, the entrant is bound to accept the new competition and these terms and conditions will apply in all respects. Under no circumstances will NZMTC be liable to the entrant if NZMTC is unable to provide a comparable competition on a rescheduled day or rescheduled time.
15. By entering the competition, you are consenting to receive further information from NZMTC.
16. Subject to any applicable law which cannot be excluded, NZMTC and any other person or party associated with the competition shall not be liable for any loss, damage or injury suffered or sustained (including but not limited to direct or consequential loss or loss arising from negligence) arising directly or indirectly out of, or in connection with the promotion or any prize.
