SPECTATORS BAR & BISTRO Gift Card Terms & Conditions

Please read these terms carefully before using your Spectators Gift Card.

1. Card Ownership

The Spectators Gift Card (the "Card") remains the property of Spectators at all times. By purchasing or using this Card, you agree to these Terms and Conditions.

Spectators management and staff reserve the right to refuse entry or Card usage at their discretion.

2. Loading Value

The following limits apply to Card value loaded at the time of purchase on premises:

- Minimum load amount: \$20.00
- Maximum load amount: \$100.00

Cards may be purchased and loaded on premise at Spectators, or purchased at the Addington Raceway & Events Centre offices, both located on Jack Hinton Drive, Addington, Christchurch.

3. Expiry

The value loaded on each Card will expire three (3) years from the original date of purchase. After this date, the Card will no longer be accepted for payment.

Any unused balance remaining on the Card at the time of expiry will not be refunded or carried over. It is the cardholder's responsibility to use the Card balance before the expiry date.

4. Redemption & Accepted Use

Card value may be redeemed for food and beverage purchases at Spectators Bar & Bistro at 65 Jack Hinton Drive, Addington, Christchurch, from Monday to Sunday during trading hours.

The Card cannot be used for the following:

- Exchanged for cash, credit, or any monetary equivalent.
- Used for purchases at any other venue within Addington Raceway or a third-party outlet.
- Used to purchase additional Gift Cards.

5. Lost, Stolen or Damaged Cards

Spectators accepts no responsibility for lost, stolen, or damaged Cards. Lost or stolen Cards will not be replaced, and no refund will be issued for any remaining balance.

Cardholders are responsible for the safekeeping of their Card. Treat your Gift Card like cash.

6. Refunds & Returns

Gift Card value is non-refundable and cannot be exchanged for cash at any time, including in the event of closure, change of management, or any other circumstance.

In the event that a purchase made using a Gift Card is subsequently refunded, the refunded value will be returned to the original Gift Card where possible.

7. Liability

To the maximum extent permitted by applicable law, Spectators will not be liable for any loss or damage arising from the use, attempted use, misuse, or inability to use this Card, including but not limited to loss caused by Card theft, fraud, or technical failure.

8. Amendments to Terms

Spectators reserves the right to amend these Terms and Conditions at any time without prior notice. The most current version of these terms will apply to all Cards. Continued use of the Card constitutes acceptance of any revised terms.

9. Governing Law

These Terms and Conditions are governed by the laws of New Zealand. Any disputes arising in connection with this Card shall be subject to the exclusive jurisdiction of the New Zealand courts.
